

CLIENT, PARENTS, AND/OR GUARDIANS - PLEASE READ

**RELEASE OF LIABILITY**

Liability Statement: Client/Parent/Guardian acknowledges that there are risks inherent with live entertainment. These include, but are not limited to, dangers from tripping over equipment, dangers from paint and paint brushes. Client/Parent/Guardian assumes the liability for all such risks and agrees to indemnify, defend and hold harmless Sasha Scanlan (“Artist”) against any and all accidents, claims, judgments, cost or liability for damage, injury to any person or property during the Event including time of setup and take down.

Client/Parent/Guardian takes full responsibility when allowing/having Artist paint their face or another extremity of their body. Artist is not liable for bodily damage caused by glitter or allergic reactions to paints. It is the Client/Parent/Guardian’s responsibility to notify the Artist if their child or other person in their party has sensitive skin. People with skin allergies or sensitive skin should either not participate, request an ingredient list, or have artist perform a patch test at the beginning of the event.

Artist can provide ingredient lists for those guests who have allergies, if requested at least 24 hours before the event.

For sanitary reason, Artist will not paint anyone who is or appears to be sick or be suffering from: cold sores; conjunctivitis, any infectious skin condition; eczema or open wounds. The artist reserves the right to refuse to paint any attendees with signs of infectious diseases at any point in the event. These determinations are at the artist's sole discretion.

If the Client/Parent/Guardian knows beforehand of any person in their party who have infectious/contagious diseases such as chicken pox, pink eye etc, the artist must be informed prior to face painting. If the client does not inform the artist beforehand, and the artist’s equipment is subsequently contaminated, the client will be invoiced for the appropriate decontamination or if necessary, replacement of any affected equipment.

Artist will use reasonable care but is not responsible for damage to clothing or property. Please note that Sasha Scanlan takes great care in precautions to assure a safe and sanitary experience. Sasha Scanlan strives to use only the safest materials, however, no product can guarantee that they will not cause a reaction on anyone. It is the client's responsibility to be aware of ingredients that they may be sensitive to, and ask for an ingredient list if desired.

For safety reasons, artist will not paint children or other persons who are unwilling.

**I, Client/Parent/Guardian, have read and understand the above Release of Liability. Specifically, I understand that there is a chance of allergic reaction to face paint and do knowingly assume such risk individually and on behalf of my guest, invitees, minors in my company, and/or authority. Further, I agree to indemnify and hold harmless Sasha Scanlan (including any persons and/or companies Sasha Scanlan is working in connection with, including, but not limited to Liz Wade Photography, managers, members, employees, and agents) from any and all accidents, claims, judgments, cost or liability for damage, injury to any person or property.**
